Nature of the business

Nebeau imports high quality cosmetics from established and renowned international manufacturers and wholesale these to South African salons. Through proper procurement practices, the Company keeps products as affordable as possible, thus ensuring that big and small salons alike can have access to high-performance products.

Our brands are focused on the hair professional to bring creativity and passion to their work every day. We therefore sell exclusively to salons and professional retail stores:

- The Company is the sole importer of *Inebrya* for South Africa. This is a premium haircare range imported from Pettenon, Italy.
- Keratin Structure is a hair Botox treatment system and home-care range imported from Edelstein, Italy;
- Our men's range, XFLEX, is imported from Edelstein, Italy;
- The Company supplies a vegan and formaldehyde free Brazilian smoothing system called Onlys. This treatment solution with its home-care range is imported from Alterlook, Spain;
- The Company also import a Black hair bleach from Alterlook, Spain.

The Company sells nationally to hair salons through a network of sales agents and representatives, whom are mostly situated in the provinces and not at Head Office.

The Promotion of Access to Information Act

The Act grants a requester access to records of a private body, if the record is required for the exercise or protection of any rights. If a public body lodges a request, the public body must be acting in the public interest.

- Provide sufficient details to enable the Company to identify:

 - The requester, and if an agent is lodging the request, proof of capacity;
 - The form of access required;
 - The postal address or email of the requester;
 - The right which the requester is seeking to exercise or protect with an explanation of the reason the record is required to exercise or protect the right.

Prescribed fees

The following applies to requests:

- A requestor is required to pay the prescribed fees before a request will be processed;
- If the preparation of the record requested requires more than the prescribed 6 hours, a deposit shall be paid (of not more than one third of the access fee which would be payable if the request were granted);
- A requestor may lodge an application with a court against the tender/payment of the request fee and/or deposit;
- Records may be withheld until the fees have been paid.
